

Background to the Commission



- There is a need to provide training opportunities for installers and supervisors in the rainscreen façade systems sector, arising from the Grenfell Inquiry.
- There is also a requirement to provide clear pathways and training standards for upskilling installers across a range of functions.
- CITB research in 2025 and previous NFRC pilots evidenced shortages of workers in this field and an additional demand for 500 specialist workers in this field per year. Evaluation report available and shared.
- In December 2024, the government published their Remediation Acceleration Plan outlining its ambition to increase the pace of remediation for buildings in England with unsafe cladding.
- CITB are seeking to support training providers to deliver rainscreen façade systems training to installers and supervisors to help to tackle the skills gaps.







CITB Proposal



- Budget £250,000 over 2 years.
 - £200,000 for first two years
 - Overachievement budget of an additional £50,000
 - Employer Network & Training Provider Network delivery
- Rainscreen Façade Systems providers to deliver:
 - Four short duration Rainscreen Façade Systems courses to 100 Rainscreen Façade Systems Installers
 - Rainscreen Façade Systems Upskilling Course to 24 Rainscreen Façade Systems Supervisors
 - To include materials and associated management and delivery costs
 - To cover England, Scotland and Wales

CITB Proposal



- Rainscreen Façade Systems Installers (four short duration courses, each six hours long):
 - Inspection of backing walls
 - Installation of carrier systems
 - Installation of cavity barriers
 - Installation of the rainscreen façade system
- Rainscreen Façade Systems Supervisors (Rainscreen Façade Systems Upskilling Course):
 - What is a rainscreen façade?
 - The legislation relevant to the installation of a rainscreen façade system in accordance with the Building Safety Act.
 - The characteristics and purpose of the component parts of a rainscreen façade system
 - Identification, recording, reporting and rectification of installation defects.

CITB Proposal




- Looking for one or more providers to cover the geographic spread.
- Providers with existing relationships with employers in the sector.
- Qualified trainers with demonstrable experience to deliver these courses (must have access to trainers).
- Trainers must satisfy CITB standards in the specification.
- Robust quality assurance processes in place, for example CITB Approved Training Organisations (ATOs).
- The tender will include costs for materials and equipment required for the training delivery.
- If delivering in Wales, Welsh translations must be provided if requested.
